Your Support at Home budget can be used on an extensive range of services tailored to your care plans, goals and preferences.

Support at Home is a government-funded initiative that supports individuals aged 65 and older in maintaining their independence at home. Once approved for funding, you can engage Benetas to create a personalised care plan tailored to your needs, and to deliver your services with quarterly budget and care reviews.

Home Care Funding and Contribution Changes

The government will continue funding in-home care, but some cost-sharing changes will apply. Instead of set fees, contributions will be based on the type of service received and financial means.

Clinical Care Services under this category include clinical nursing care, physiotherapy and other Allied Health services. Care Management also falls under this category.	Fully funded via your package	No cost to client

Assistive Technology and Home Modifications (AT-HM)

Funding up to \$15,390.00 per assessed need

AT-HM is a separate scheme to provide funding for equipment and home modifications, with three funding tiers - low, medium and high depending on assessed needs.

Restorative Care Pathway

This short-term support is designed to help participants regain strength and delay the need for ongoing services. It extends the previous 8-week program to up to 16 weeks, offering funding of up to \$6,000 per episode, with higher amounts available for those with more complex needs.



End-Of-Life Pathway

For those wishing to stay at home in their final months, this pathway provides intensive support over a 12-week period. A one-off budget of \$25,000 is available for eligible participants through the End-of-Life Pathway.
